

THE CONSUMER PRICE INDEX

1. Monthly Change

The Index for month of June 2011 registered a 97.97 index change which show a decreased by 0.11 percent from the previous month of May 2011. The Table below validates the variations of the CPI index between the two observation periods and enclosed in Appendix 1 is the CPI market basket for comparisons. Similarly the annual CPI market basket is attached in Appendix 2 as well as Technical notes in Appendix 3 for readers/users reference.



1.1 Monthly Observation

As illustrated in the Table above and Chart 1 the June 2011 Consumer Price Index posted a small decrease of 0.11 percent from last month. The overall decline is impacted by the slight decline of the Food group with 0.34percent drop. This is attributed by little declines of 1 kg self raising flour (4.91%), tinned corn beef (2.54%), tinned mackerel (4.78%), onions per kg (1.45%) and cooking oil (3.18%). The Food index has continued decreasing since February 2011 and has been impacting the overall CPI deflation since.

On the contrary, four of the seven groups have posted insignificant gains which are lead by Miscellaneous with 0.71 percent, then Transport & Communications with 0.40 percent. Within the Miscellaneous group small surge of canned dog food, bathing soap and deodorant has impacted the change while slight increase of petrol prices has impacted the variation of the Transport & Communication group.

Also posting small gains is the Household operations and Clothing indexes with 0.11 and 0.09 percent respectively while Alcohol & Tobacco and Housing group remained constant throughout this period.

2. Annual Change

The Year to date change posted a decline in Nauru's CPI to 0.97 percentage compared to June 2010, with the main contributors to the annual deflations being;—Alcohol & Tobacco, Housing and Miscellaneous.




Chart 2. Annualised % change since June 2010

2.1 Annual Observation

The year to date change reported deflations for goods and services on three of the seven major groups. Heading the annual deflation is the Alcohol & Tobacco index posting the largest fall of 9.28 percent. The single falling index of cigarettes (11.65%) has contributed to the group decline.

Housing group also posted a decline with 3.22 percent compared to a year ago and is attributed to drops in timber (15.79%) and paint (7.69%). Miscellaneous group posted the lowest annual deflation with 1.27 percent and the sole contributing component is the decrease of bathing soap with 12.50 percent reduction.

To offset the deflations four groups posted annual growths namely Transport & Communications, Household operations, Clothing and Food. Transport & Communications posted the highest growth with 3.66 percent and is influenced by surges in oil and petrol with 22.74 and 4.70 percentage increases respectively. Household operation posted a 2.54% growth and the contributing factors is attributed to Clothing group posted 0.63 percent growth which is attributed to the increase of women's slip on shoes with (4.53). Also Food index rose insignificantly by 0.54 percent compared to a year ago and within Food, the increase be traced to significant increases for coffee (11.21%), chicken cuts (6.52%), and noodles (6.41%).

3. All Groups CPI Series

The All Groups CPI Series (Chart 3) depicts historical data for the past 24 months which have two measuring components. First the bar graphs point out the percentage movements of the All Groups CPI from one month to the other. The line graph depicts the percentage change from CPI base period (August 2008) to corresponding monthly CPIs.




Chart 3. All Groups CPI Monthly variables and Inflation trend since base period

3.1 Historical Outlook

i. Change on a Monthly basis

It is evident that in mid 2009 the rise of global prices of rice has correlated with the surge of inflation in Nauru's CPI with rice prices reaching record levels. The commodity rice is ranked the highest commodity according to its relative importance out of all the goods and services available within Nauru's CPI market basket. Since that event the volatile CPI has been fluctuating according to local demand and supply of goods and services.

ii. Inflation change since base period

It is apparent that current prices are well below base prices and has remained on the negative since mid 2010 except for January 2011 where slight surge was based on inflated prices for the New Year. The most noticeable indexes that have influenced this trend are Alcohol & Tobacco and Transport & Communications which have gradually declines overtime compared to base period. Inflation change since base period continued to trend downward

4. Conclusion

The observation for the monthly, annualised and historical trends posted insignificant changes for this period which are virtually unchanged. But in the context for the current prices the outlook is trending downwards when compared to base prices in 2008.

In comparison, the Global Food Prices publications observed by FAO, prices have slightly declined for June 2011 and it's attributed by slipping prices of cereals and sugar. However, according to the Food Outlook report forecast estimates will remain high for the rest of this year and into 2012.

Technical Notes

Brief Explanation of the CPI

The Consumer Price Index (CPI) is a measure of the average change in prices over time of goods and services purchased by households. The basis of goods and services included in the CPI market basket is subsequently the basis for analysis of consumer spending from the Household Income & Expenditure Survey (HIES) carried out by the Bureau of Statistics in 2006. The bureau is mandated to publish monthly CPIs.

The CPIs are based on prices of food, clothing, beverages, fuels, transportation fares, household supplies and other goods and services that people buy for day-to-day living. Prices are collected each month across the island from 6 retail establishments, and other service providers associated within the CPI market basket. Prices of most goods and services are obtained through personal visits by Statistics staff and additional publications such as the Fuel Watch and public notices that reflect the goods and services within the CPI market basket. In calculating the index, price changes for the various items in each location are averaged together with weights that represent their importance. Local data are then combined to obtain a national average.

The index measures price change from a designated reference date. For the CPI, the reference base is 2008= 100.00. An increase of 16.5 percent from the reference base, for example, is shown as 116.5. This change also can be expressed in dollars as follows: the price of a base-period market basket of goods and services in the CPI has risen from \$10 in 2008 to \$11.65. Calculating index changes

Movements of the indexes from one month to another usually are expressed as percent changes, rather than changes in index points, because index point changes are affected by the level of the index in relation to its base period, whereas percent changes are not. The example shown in the box on this page illustrates the computation of index point and percent changes.

Percent changes within the CPI publication reflects for (1) monthly, (2) annual and (3) historical trends since base period are computed according to the standard formula for compound growth rates. These data indicate what the percent change would be if the current rate were maintained for the 3 periods specified in the latter.
